
FILING OF A SERVICE CHARGE REPORT; PUBLIC HEARING ON: THE SERVICE CHARGE REPORT

The Board of Directors of County Sanitation District No. 2 of Los Angeles County will hold a public hearing on May 9, 2018, 1:30 p.m., in the Board Room at the District's Administrative Offices, 1955 Workman Mill Road, Whittier, CA 90601. The purpose of this hearing is to provide the public with an opportunity to make comments regarding the Service Charge Report filed with the District Clerk on April 11, 2018. The boundaries of Sanitation District No. 2 are shown below.

Sanitation District No. 2 provides wastewater collection, treatment, and disposal services. Residential and commercial users pay for their share of these services through the District's service charge program. The average daily quantity of sewage flow and strength from one single family home is equal to one sewage unit. All other user categories are assessed proportionately. The service charge rate for fiscal year 2018-19, as previously approved by the District's Board of Directors on May 10, 2017, is \$173 per year per sewage unit.

The District intends to continue to collect the service charge as a separate line item on the property tax roll as the most cost-effective means of collecting the charges. In order to do so, the California Health and Safety Code requires the filing of and subsequent hearing on a Service Charge Report. Copies of the Report are available on the District's website (www.lacsd.org) or can be obtained by contacting District's staff by regular mail at P.O. Box 4998, Whittier, CA 90607-4998; by e-mail at Rates@lacsd.org; or by phone at (855) 240-9506 (toll free).

In addition to providing comments at the public hearing, written comments regarding this matter may also be submitted to the District Clerk at these same addresses. Written comments must be received by 10:30 a.m., May 9, 2018, to allow for processing prior to the hearing.
