SECTION 1. Section 29-6.4 of Chapter 29, Artcle II of the Paramount Municipal Code is hereby amended by adding subsection (m) to read as

"(m) A person shall not park or let stand any vehicle, unless such vehicle displays a permit authorized hereunder on the 16400 block of California Avenue and 8018 Jackson Street, 8024 Jackson Street, and 8030 Jackson Street.

This Ordinance is not subject to the California Environmental Quality Act ("CEQA") pursuant to §§ 15060 (c) (2) (the activity will not result in a direct or reasonable foreseeable indirect physical change in the environ-ment) and 15060 (c) (3) (the activity is not a project as defined in § 15378 of the CEQA Guidelines Title 14, Chapter 3 of the California Code of Regulations) because it has no potential for resulting in physical change to the environ-ment, directly or indirectly.

SECTION 5. Severability. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council of this City hereby declares that it would have adopted this Ordinance and each section, subsection, sentence, clause or phrase, or portion thereof, irrespective of the fact that anyone or more sections, subsections, clauses, phrases, or portions are declared invalid or unconstitutional.

SECTION 6. Effective Date. This Ordinance shall take full force and effect thirty (30) days after its adoption.

SECTION 7. The City Clerk shall certify to the adoption of this Ordinance and shall cause the same to be posted as required by law.

ORDINANCE NO. 445

The City Attorney has prepared the following Summary of Ordinance No. 445:

Ordinance No. 445 amends Chapter 12.20 (Park Regulations) of the Lemon Grove Municipal Code. It changes Park hours to "dawn to dusk" instead of seasonal specific hours. It bans the alcohol consumption in parks. It also adds marijuana to the "no smoking" in parks ban that prohibits any smoking "tobacco or vaping" in parks. These changes apply to all public parks in-cluding the Main Street Promenade. This Ordinance was introduced on May 16, 2017, and was adopted on June 6, 2017.
