AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PARAMOUNT AMENDING SEC TION 29-6.4 OF CHAPTER 29. ARTICLE II OF THE PARAMOUNT MUNICIPAL CODE AU-THORIZING LIMITING OR STOPPING, STAND-ING OR PARKING IN DESIGNATED TOW AWAY ZONES

THE CITY COUNCIL OF THE CITY OF PARA-MOUNT DOES HEREBY ORDAIN AS FOL-

SECTION 1. Section 29-6.4 of Chapter 29, Article II of the Paramount Municipal Code is hereby amended in its entirety to read as follows:

'The City Council is authorized under California Vehicle Code Section 22507(a)(b) to establish by ordinance or resolution procedures to designate certain streets upon which parking privileges are given to residents and their guests, under which the residents may be issued a permit or permits that exempt them from the prohibition or restriction of the ordinance or resolution.

SECTION 2. Authority. This Ordinance is adopted pursuant to the provisions of Section 22507 of the California Vehicle Code, and as amended.

SECTION 3. CEQA. This Ordinance is not subject to the California Environmental Quality Act CEQA") pursuant to §§ 15060 (c) (2) (the activity will not result in a direct or reasonable foreseeable indirect physical change in the environment) and 15060 (c) (3) (the activity is not a project as defined in § 15378 of the CEQA Guidelines Title 14, Chapter 3 of the California Code of Regulations) because it has no potential for resulting in physical change to the environ-ment, directly or indirectly.

If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council of this City hereby declares that it would have adopted this Ordinance and each section, subsection, sentence, clause or phrase, or portion thereof, irrespective of the fact that anyone or more sections, subsections, clauses, phrases, or portions are declared invalid or unconstitutional.

SECTION 5. Effective Date. This Ordinance shall take full force and effect thirty (30) days after its adoption.

SECTION 6. The City Clerk shall certify to the adoption of this Ordinance and shall cause the same to be posted as required by law.

Sexual harassment by a landlord or anyone related to your housing violates the Fair Housing Act. if you receive unwelcome sexual advances or are threatened with eviction because you refuse to provide sexual favors, you may file a fair housing complaint.
