NOTICE OF INTENTION TO CIRCULATE RECALL PETITION

To the Honorable Diane J. Martinez: Pursuant to Section 11020 of the California Elections Code, the undersigned registered qualified voters of the City of Paramount, in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of Council Member in the City of Paramount, California, and to demand election of a successor in that office.

The grounds for the recall are as follows:

Let Paramount Vote In November 2018: This year, Governor Brown signed 2 new voting rights bills, SB 415 and SB 568 to combat low voter turnout, especially in local jurisdictions such as Paramount. Presently, in California's municipal government jurisdictions, an alarmingly small percentage of its residents decide a local election. This pattern is especially pronounced in off-cycle "stand alone" local elections, when turnout rates typically lag those of local elections that coincide with statewide and national contests. The difference in voter turnout can be traced to a single factor – election timing.

Under SB 415 and SB 568 the City of Paramount now has the legal options to hold its next Municipal Election on November 6, 2018 to coincide with California's General Election. At the present time, within a fifteen mile radius of Paramount, 15 municipal jurisdictions will be holding their elections on November 6, 2018. Additionally, the Paramount Unified School District will hold its first even-year Board of Education Election on November 6, 2018.

The proponents of this recall petition have determined that you are opposed to increased voter participation in Paramount's Municipal Elections and reluctant to reschedule the date to coincide with the November 6, 2018 statewide election.
