ORDINANCE SUMMARY OF ORDINANCE NO. 1127

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PARAMOUNT AMENDING SECTION 29-6.4 OF CHAPTER 29, ARTICLE II OF THE PARAMOUNT MUNICIPAL CODE GRANTING AUTHORITY TO LIMIT OR PROHIBIT STOPPING, STANDING OR PARKING IN DESIGNATED TOW AWAY ZONES

On March 17, 2020, the Paramount City Council voted to introduce and pass to second reading Ordinance No. 1127 which amends the Municipal Code to include residents of 14819 Downey Avenue, Paramount, California in the process for issuance of parking permits in certain areas that limit or prohibit stopping, standing or parking in designated tow away zones.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PARAMOUNT AMENDING SECTIONS 10-1, 10-2, 15-1, 27-1 AND 32-1 OF THE PARAMOUNT MUNICIPAL CODE, ADOPTING BY REFERENCE THE 2019 CALIFORNIA BUILDING CODE, RESIDENTIAL CODE, GREEN BUILDING STANDARDS CODE, ELECTRICAL CODE, MECHANICAL CODE, AND PLUMBING CODE WITH THE LOS ANGELES COUNTY AMENDMENTS AS NOTED IN TITLE-26 AND APPENDIX I AND J, TITLE-27, TITLE-28, TITLE-29, TITLE-30 AND APPENDIX H, AND TITLE-31 PORTIONS THEREOF
