WHAT TIME IS IT?

The answer to that question depends upon where you are in the world. At midday in Chicago, your watch might read 12 p.m., Friday, January 15, 2010, whereas in Sydney, Australia, it would read 5 a.m., Saturday, January 16, 2010.


The difference in time around the world has to do with the International Date Line and time zones. The International Date Line is an imaginary line in the middle of the Pacific Ocean that divides the earth into two days. Generally places in the eastern hemisphere are a day ahead of places in the western

Earth is divided into time zones. The United States has several, including Eastern, Central, Mountain and Pacific Standard Time. Generally, the farther west the area, the earlier in the day it is. At 7 p.m. Central Time in Chicago, it is 6 p.m. Mountain Time in Denver and 5 p.m. Pacific Time in Los Angeles

Most clocks have two arrows. The short arrow is known as the little hand and tells the hour. The long arrow is known as the big hand and tells the minute. When the little hand is on 11 and the big hand is on 12, for example, it is 11 o'clock. Write in the time under each clock face pictured.
