AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PARAMOUNT SETTING FORTH ITS FINDING OF FACT, AND APPROVING ZONING ORDINANCE TEXT AMENDMENT NO. 17, AMENDING CHAPTER 44, ARTICLE I, SEC TION 44-1 (DEFINITIONS), AND ADDING ARTICLE XXVIII OF THE PARAMOUNT MUNICIPAL CODE, ESTABLISHING REGULATIONS FOR ART IN PUBLIC PLACES ON PRIVATE LAND CITYWIDE
