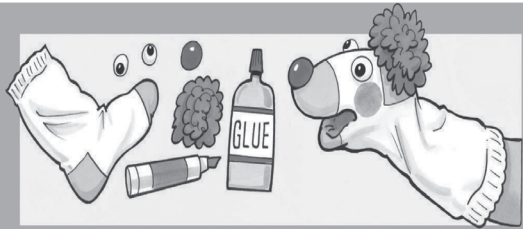


# KID'S CORNER



## A Puppet of Your Own

You don't have to be a great artist to make a great puppet. All you need is a sock, a few art supplies and some imagination.

Any sock you can slide your hand into and move it around will work for a puppet. If you plan to draw a face on your sock puppet, you might want to get a white sock. Slide the sock onto your hand, close your hand and mark where you think the eyes, nose and mouth should go. Then sketch or glue them on if using felt.

Once your puppet has a face, you can give it a name and start practicing with it. You'll want to try different voices and hand positions to bring your puppet to life.
