PROPOSED CONDITIONAL USE PERMIT NO. 922

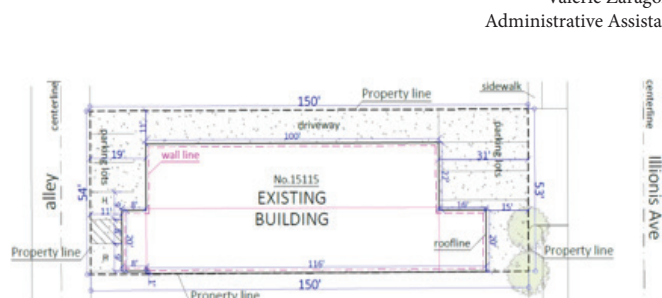
