On March 26, 2024, the Paramount City Council voted to introduce Ordinance No. 1184, adding Chapter 2.20 to Title 2 of the Paramount Municipal Code pertaining to the official City seal, logos, insignias, and other identifiable markings to ensure they are fully protected and utilized for appropriate circumstances only.

The City Council of the City of Paramount, on the 26th day of March 2024, read by title only and introduced Ordinance No. 1184 by the following roll call vote:

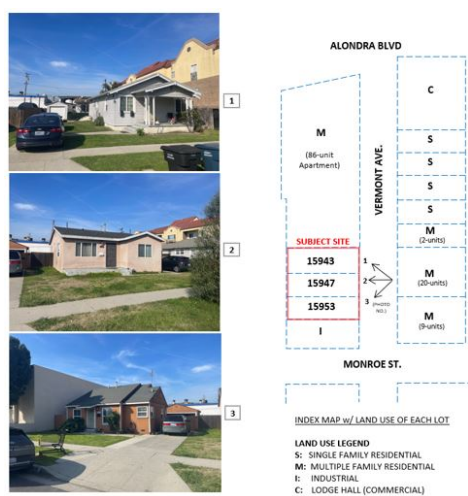

### CITY OF PARAMOUNT NOTICE OF PUBLIC HEARING



The City of Paramount has been evaluating zoning designations in areas throughout the City. For years, some residential properties on Vermont Avenue between Monroe Street and Alondra Boulevard have been designated as M-1 (Light Manufacturing) in the City's Zoning Map. This industrial designation exists even though these properties are residential. To provide a more accurate zoning designation for these properties, the City of Paramount is proposing to change the zone to R-M (Multiple-Family Residential). If approved, this would mean industrial businesses would no longer be allowed on these properties. The Planning Commission recommended approval last month. You are invited to a Public Hearing to hear more about the proposed changes.
