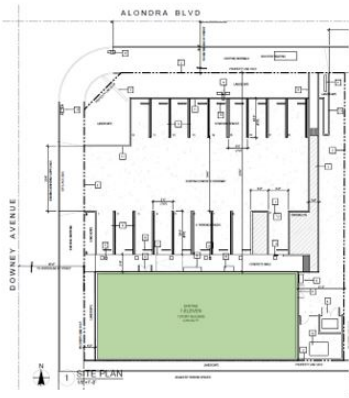

On March 13, 2002, the Paramount Planning Commission approved Conditional Use Permit No. 516 for 7-Eleven to sell beer and wine for off-site consumption at the 7 Eleven on the corner of Alondra Boulevard and Downey Avenue. The store operates 24 hours daily with alcohol sales occurring from 6 a.m. to 2 a.m. This 7-Eleven store is now applying to also sell distilled spirits. The sale of spirits would be limited to a small, locked display shelf that is only accessible to store employees.

Non-residential commercial property and property upon which there is a recorded nuisance abatement lien shall be subject to the tax collector's power to sell and eligible for sale at the County's online auction in 2026.
