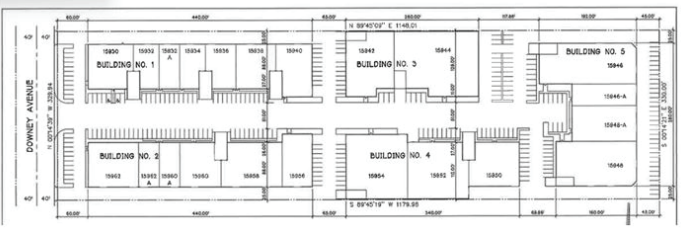

In 1988, Paramount voters approved Proposition FF, which limited most housing density to 22 homes per acre. The exception is senior citizen housing, which could be 70 homes per acre. Since 2021, the City of Paramount has followed State of California requirements and has considered the provisions of Proposition FF inapplicable by operation of law. In 2022, the California Department of Housing and Community Development (HCD) certified the City's Housing Element (which is the housing plan that all cities in California must complete every eight years) with a requirement for the City to formally clarify that Proposition FF is now inapplicable. The proposed Zoning Ordinance Text Amendment meets that requirement.
