NOTICE OF ZONING ORDINANCE TEXT AMENDMENT

In late 2025, Governor Newsom signed Senate Bill (SB) into law. SB 79 requires certain cities and counties to approve increased housing density near transit by introducing new development standards for properties near defined Transit-Oriented Development (TOD) stops. SB 79 includes regulations for housing density (homes per acre) and height. SB 79 allows a city to enact an ordinance that includes objective development standards, conditions, and policies applying to transit-oriented housing developments.

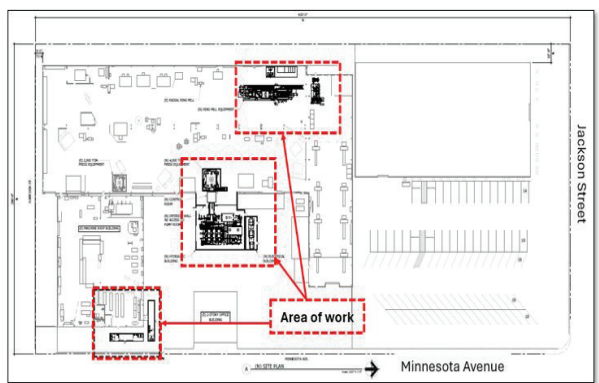

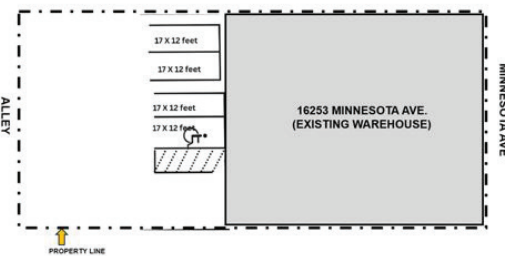
