#### ORDINANCE SUMMARY OF ORDINANCE NO. 1217

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PARAMOUNT, APPROVING ZONING ORDINANCE TEXT AMENDMENT NO. 41, AMENDING CHAPTER 17.20 (INITIATIVE REGULATING DENSITY) OF TITLE 17 (ZONING) OF THE PARAMOUNT MUNICIPAL CODE TO IMPLEMENT PROGRAM 22 OF THE 6TH CYCLE HOUSING ELEMENT PROGRAM BY CLARIFYING THE APPLICABILITY OF PROPOSITION FF AND MAKING A FINDING OF EXEMPTION UNDER THE CALIFORNIA ENVIRONMENTAL QUALITY ACT

On April 28, 2026, the Paramount City Council voted to introduce Ordinance No. 1217, an ordinance of the City Council of the City of Paramount approving Zoning Ordinance Text Amendment No. 41, Amending Chapter 17.20 (Initiative Regulating Density) of Title 17 (Zoning) of the Paramount Municipal Code to implement Program 22 of the 6th Cycle Housing Element Program by clarifying the applicability of Proposition FF and making a finding of exemption under the California Environmental Quality Act.

The City Council of the City of Paramount, on the 28th day of April 2026 introduced Ordinance No. 1217 by the following roll call vote:
