REGARDING THE CITY COUNCIL'S INTENTION TO PLACE ON THE BALLOT A MEASURE TO LEVY A SPECIAL PARCEL TAX TO FINANCE ROADS AND INFRASTRUCTURE, PUBLIC SAFETY SERVICES, ENVIRONMENTAL SERVICES, AND BUSINESS REINVESTMENT PROGRAMS

NOTICE IS HEREBY GIVEN that the City of Paramount shall conduct a public hearing to consider placing the following special tax measure on the ballot for the November 3, 2026 election:

Without taxing residential property owners or renters, shall the ordinance to fund services for Paramount 911 response/public safety; reducing crime; responding to business burglaries; addressing street racing; monitoring/improving water/air quality; repairing streets/potholes; supporting businesses by annually levying between 8¢ and 13¢ per square foot on industrial/commercial properties only, with annual adjustments up to 3%, raising approximately \$4,000,000 annually until ended by voters, requiring audits, spending disclosure, local control, be adopted?

The public hearing will be held at the regularly scheduled City Council meeting at 5:00 p.m. on Tuesday, July 28, 2026 in the Council Chamber at City Hall, 16400 Colorado Avenue, Paramount, California. Participants may provide their comments orally, in writing, or via email at crequest@paramountcity.gov. Email comments must be received by 4:45 p.m. on Tuesday, July 28, 2026. Additional options for public participation may be provided at the time the agenda is posted.

Govt. Code Section 50077 provides that before the City may propose by ordinance or resolution the adoption of a special tax, the Council must hold a noticed public hearing to consider the ordinance or resolution adopting the special tax. The proposed tax must be placed before the voters and approved by two-thirds of the votes cast.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PARAMOUNT, APPROVING ZONING ORDINANCE TEXT AMENDMENT NO. 42, ADDING DEFINITIONS TO SECTION 17.04.010, AMENDING SECTION 17.60.030(A), AND ADDING CHAPTER 17.18 (TRANSIT-ORIENTED DEVELOPMENT OBJECTIVE DESIGN STANDARDS) TO TITLE 17 OF THE PARAMOUNT MUNICIPAL CODE, AND MAKING A FINDING OF EXEMPTION UNDER THE CALIFORNIA ENVIRONMENTAL QUALITY ACT

On June 23, 2026, the Paramount City Council voted to introduce Ordinance No. 1219, an ordinance of the City Council of the City of Paramount approving Zoning Ordinance Text Amendment No. 42, adding definitions to Section 17.04.010, amending Section 17.60.030(a), and adding Chapter 17.18 (Transit-Oriented Development Objective Design Standards) to Title 17 of the Paramount Municipal Code, and making a finding of exemption under the California Environmental Quality Act.
